Notice of opening of the Competition for the award of Research Initiation Grants

A competition is open for the award of 1 Research Initiation Grant (BII) within the scope of

the CISeD Research and Development Unit, with reference UIDB/05583/2020, financed by

national funds through FCT/MCTES to under the Collaboration Protocol for funding granted

by the Foundation for Science and Technology (FCT), within the scope of the Regulation

for Evaluation and Multi-annual Financing of R&D Units, under the following conditions:

1. Sources of Funding: The project is financed by funds from the State Budget through

FCT/MCTES-Ref^a UIDB/05583/2020

2. Scientific Area: Management / Marketing

3. Admission requirements: Students enrolled in a professional higher technical course or

in a degree in the field of communication, marketing, advertising and public relations,

management or related areas, or graduates in the scientific area of communication,

marketing, advertising and public relations, management or similar, enrolled in courses that

do not lead to an academic degree as part of the educational project of a higher education

institution, developed in association or cooperation with one or more R&D units.

4. Hiring Requirements:

4.1. On the date of hiring, you must submit a document proving acceptance by the host

institution, guaranteeing the necessary conditions for the good development of the work;

4.2. At the date of hiring, you must also meet one of the following conditions:

a) Be enrolled in a degree in the field of communication, marketing, advertising and public

relations, management, or related areas.

b) Be enrolled in a course that does not award an academic degree as part of the educational

project of a higher education institution, developed in association or cooperation with one or

more R&D units.



- **5. Preferential Conditions:** The following constitute preferential conditions:
 - Academic and scientific training will be valued, as well as participation in research, demonstration and dissemination activities, professional experience and knowledge in the areas of communication, marketing, advertising and public relations, management.
 - Good communication skills and fluency in oral and written Portuguese and English;
 - Initiative, ambition and motivation to work as a team;
- **6. Work plan:** Develop research activities under the guidance of the Principal Investigator PHD Professor Luísa Paula Lopes Fernandes Augusto, which include 1) Support in reviewing the literature on the topic; 2) Continue the relationship with project partners; 3) Support in data collection through questionnaires; 4) Support in the preparation of material for technical and scientific dissemination; 5) Participation in activities to promote and disseminate project results (conferences, seminars, etc.).
- **7. Applicable legislation and regulations:** Law No. 40/2004 of August 18, which approves the Research Fellow Statute, amended by Decree-Law No. 202/2012 of August 27, by Law No. 12/2013, of 29 August January, by Decree-Law No. 89/2013, of July 9th and by Decree-Law No. 123/2019 of August 28th, FCT Research Grant Regulations, available at and https://www.fct.pt/ Apoios/bolsas/regulamento.phtml.pt and Regulation of Research Grants of the Polytechnic Institute of Viseu, published in the Diário da República, no. 112, 2nd series, of June 9, 2020.
- **8. Workplace:** The work will be carried out at the facilities of the Polytechnic Institute of Viseu and in the laboratories of its integrated schools, in particular ESEV, under the scientific guidance of Professor Luísa Paula Lopes Fernandes Augusto.
- **9. Duration of the scholarship:** The scholarship will last for 4 months, possibly renewable, and cannot, in any case, exceed the end of the financing.
- **10.** Value of the monthly maintenance subsidy: The amount of the scholarship will be €601.12 according to the table of current scholarship values set for this type of scholarship

Payment of the scholarship is made between the 20th and 30th of each month by transfer to the Grantee's NIB indicated in the Contracting Process.

11. Selection methods: The selection methods to be used will be the following: Curricular Assessment and Selection Interview, with candidates who obtain a classification greater than 10 points in the Curricular Assessment being selected for the interview.

In the Curricular assessment, each factor considered will be expressed on a scale of 0 to 20 values. The Curricular Assessment (CA) will have a weight of 80% in the classification formula and is expressed in the following formula:

AC= (80%*HA) + (20%*EP) where: AC - Curricular Assessment, HA - Academic Qualifications, EP - Professional Experience

The Selection Interview (ES) will have a weight of 20% in the Final Classification (CF) formula, with the results expressed on a scale of 0 to 20. The final ranking of candidates will be expressed from 0 to 20 values, taking into account the weighting attributed to Curricular Assessment (AC).

12. Composition of the Selection Jury:

Substitute member: Professor Paulo Alexandre Pires Pinto da Silva, Adjunct Professor at the Escola Superior de Educação de Viseu;

13. Method of publishing/notifying the results: The final results of the selection process will be published in an ordered list posted in a visible and public place in the Central Services of the Polytechnic Institute of Viseu; Notifications to candidates will be made via email.



By decision of the jury, a pool of candidates may be created, valid for 18 months after the date of completion of the selection process.

The final results will always be conditioned and subject to the obligation to comply with the provisions of the Research Fellow Statute.

A complaint may be filed based on the final deliberation of the jury, to be presented within 15 working days from the respective notification, in accordance with the provisions of article 10 of the Research Grants Regulations of the Polytechnic Institute of Viseu.

14. Contract and final report model: The contract and final report model to be prepared by the fellow and the supervisor are those attached to the IPV research grants regulations.

15. Application deadline and form of submission of applications:

The competition is open from 22/07/2024 to 02/08/2024, with applications only being accepted within the established deadline.
