Regulation for Abstract Submission – e-Posters

International Live's 2025 Congress

The Organizing Committee of the International Live's 2025 Congress invites all interested participants to submit scientific abstracts for presentation in e-poster format. The selected e-posters will be displayed during the event on digital screens located at the entrance of the main auditorium.

1. General Conditions

- Only original and unpublished work, aligned with the thematic areas of the Congress, will be accepted.
- No oral presentation of e-posters will be conducted.
- All accepted abstracts will be published in the Congress Abstracts E-Book (with its own ISBN).
- The highest-quality submissions may be selected for invitation to submit a full manuscript to the journals SERVIR and Millenium Journal of Education, Technologies, and Health, in accordance with the respective editorial guidelines.
- An award will be conferred for the Best e-Poster.

2. Deadlines and Submission Procedures

- Abstracts must be submitted by 22 November 2025.
- Submission must be completed exclusively using the official template provided by the Organizing Committee.
- Abstracts should be submitted using the template available on the website and sent to the official Congress email address: lives2025.eposter@gmail.
- The submitting author will receive an email confirmation upon successful submission.
- Only abstracts from authors/presenters with duly completed Congress registration will be included in the Abstracts E-Book.

3. Abstract Structure

- Title (maximum 100 characters; uppercase).
- Authors (up to 8; indicate presenting author and institutional affiliation).
- Keywords (up to 5).
- Introduction (including objectives).
- Methods.
- Results.
- Conclusions.
- References (maximum 5; APA style).
- Maximum length: 350 words.

4. e-Poster Submission

- Accepted works must be submitted in JPEG/PDF format, using the official template, by 26 November 2025.
- Recommended dimensions: 1920 × 1080 px (vertical orientation).
- The file name must correspond to the title of the work.
- Legibility must be ensured at a viewing distance of 2 metres.
- Failure to comply with the deadlines or with the official template will result in exclusion of the e-poster.

5. Evaluation Process

- The evaluation of abstracts is the sole responsibility of the Scientific Committee.
- The decision issued by the Scientific Committee is final and not subject to appeal.
- Evaluation criteria include: scientific relevance, clarity, innovation, and methodological rigour.
